How do I apply for my visa to attend the Global Alliance Regional Meeting?

Requirements to apply for visitor visas without permission to carry out a remunerated activity. To obtain a Mexican visa in your ordinary passport, you must present the following:

1. A passport or identification document, original and copy, that is valid for six months after your travel date.
2. A color photograph from the front with the face visible and without glasses, passport size, and with a white background. The measurements must be a minimum of 32 mm x 26 mm and a maximum of 39 mm x 31 mm.
3. The original and copy of the document that proves legal stay if the foreign person is not a national of the country where the visa is requested.
4. One of the following documents, as applicable, to certify that the foreign visitor will not carry out a remunerated activity in the country.

A. Root: 1. Original and copy of public deed of real estate duly registered in the name of the applicant with a minimum age of two years and proof of stable employment with a minimum age of two years, or 2. Original and copy of public deed of real estate duly registered in the name of the applicant with a minimum age of two years and a document proving ownership or participation in business issued by the competent authorities of each country with a minimum age of two years.

B. Financial solvency: 1. Original and copy of the documents that demonstrate that you have employment or pension with monthly income free of taxes greater than the equivalent of 100 days of the general minimum wage in force in Mexico City, during the last three months and proof of stable employment with at least one year of seniority, or 2. Original and copy of proof of investments or bank accounts with an average monthly balance equivalent to 300 days of the general minimum wage in force in Mexico City during the last three months.

C. Invitation from an organization or a public or private institution: 1. Original of the responsive letter from an organization or a public or private institution that invites the foreign person to participate in an unpaid event or activity in national territory. The letter must contain the following information: a) Full name of the applicant and nationality b) Name or company name of the organization c) Official registration number, as appropriate d) Purpose of the organization or private or public institution e) Complete address and contact information of the organization or institution f) Information about the activity that will be carried out or the project in which the foreign person will participate; The activity of the foreign person must be related to

the purposes of the organization or institution that invites g) Estimated duration or approximate date of completion of the activity to be carried out h) Commitment to take charge of the maintenance of the foreign person during their stay in Mexico and your return to your country of origin or residence ii) Copy of official identification with signature and photograph of the person signing the responsive letter

2. In order to prove that it has the resources to fulfill the obligation referred to in subsection h) of the previous section, the organization or private institution that invites will present the original and a copy of proof of investments or bank accounts with an average monthly balance equivalent to 1,000 days of current minimum wage in Mexico City, during the last 12 months.

3. Documents with which the foreign person proves that they have the experience, capacity, skills or knowledge necessary to carry out the activity for which they are invited, in original and copy.

D. Participation in an event sponsored and sponsored by the Federal Public Administration as well as by autonomous constitutional bodies. 1. Original of the letter from the agency or autonomous constitutional body that invites the foreign person to participate in an event derived from international commitments contracted by the Mexican State for the celebration of events. The letter must contain the following information: a) Full name of the applicant, b) Nationality, c) Name of the agency of the Federal Public Administration or autonomous constitutional body, d) Information about the event in which the foreign person will participate

e) Duration and date of the event f) Signature and position of the official of the Federal Public Administration or constitutional autonomous entity responsible for coordinating the event g) Original of the letter or note from the institution of the country that sends you.

TAKE INTO ACCOUNT THAT Alliance members who must present a visa must present the invitation letter described in Annex C, in addition to proving financial solvency and the details of their trip. It is highly recommended to have at the time of starting the process the round-trip plane ticket, the reservation for the host hotel, and proof that you have the experience, capacity, skills or knowledge necessary to carry out the activity for which you are invited. that is, titles, documentation that accredits you as the owner of an NGO, or any other documentation requested at the Mexican consulate.
