

LETTER FROM THE EXECUTIVE DIRECTOR



According to the World Health Organization's *Global status report on road safety 2023*, 10 countries have halved road fatalities in the last 10 years and 35 countries have reduced fatalities by 30% to 50%. This shows us that Sustainable Development Goal (SDG) 3.6—halve the number of global deaths and injuries from road traffic crashes by 2030—is achievable, but only if governments take serious action now. There is a lot to do: 3,200 people are killed every day in road crashes around the world. That is two people every minute. And, regrettably, during this same decade, road deaths increased in 65 countries.

While the number of deaths has marginally dropped, the number of motorized vehicles on the world's roads has tripled. This growth is unsustainable, threatening people's safety and the planet's future. It is time to rethink mobility, remembering that we don't move cars, we move people. Our cities and communities must reflect this.

What will it take for every country to halve road fatalities by 2030? Accountability is at the heart of achieving the target. In particular, governments must recognize that people's journeys—and consequently, their health, well-being, educational and occupational ambitions, and economic security—rely on access to safe roads. As leaders, they are responsible for ensuring that safety. NGOs are tasked with keeping leaders accountable for these responsibilities, and we, the Global Alliance of NGOs for Road Safety, are here to equip those NGOs to fulfill their roles.

Since 2020, when we published *The Day Our World Crumbled: the Human Cost of Inaction on Road Safety*, a report based on the experiences of more than 5,000 people around the world, we have been working to quantify what accountability means in road safety and how we can equip NGOs with tangible ways to integrate accountability into their advocacy. The Accountability Toolkit, launched this year, is the culmination of this work. It offers a set of practical, web-based tools that break accountability down into concrete steps that NGOs can follow to ensure that their governments are living up to their responsibilities through investment in evidence-based interventions, involving civil society in decisions that affect them.

To underpin our vision, we have published the new *Strategic Plan 2024–2030:* From Global Commitments to Local Implementation. It describes how we will lead, mobilize, and equip our network of more than 350 NGOs in 100 countries. Our NGOs are changing laws, influencing the design of streets, and ensuring that communities participate in the decisions that affect their daily lives. We unite, strengthen, and amplify their voices, representing local realities to a global community.

Join us. Together we can make a difference.


OUR STRATEGIC PLAN



ACHIEVING OUR VISION



A STRONG NETWORK

Stronger and more urgent community demand is needed for safe roads around the world. A large network of established NGOs with a track record in advocacy and the ability to present and represent local realities and people's experiences is key to creating this demand.

Amplifying the voice of NGOs Eight Global Meeting

The Eight Global Meeting of Nongovernmental Organizations Advocating for Road Safety and Road Victims (Global Meeting) was the primary gathering of road safety NGOs in 2023. The Global Meeting unites Alliance members alongside global partners, government decision-makers, and corporate sponsors. It is a platform to mobilize NGOs for global and local in-country advocacy through inspiration from global experts, capacity-building connections, and networking and sharing. The Eighth Global Meeting, centered on the theme "Rethinking road safety: Mobility for people and planet," centered on accountability for the 2030 targets through the launch of the Accountability Toolkit and training for NGOs on how to use it. Through the Symposium, this theme was explored further, building the connection between accountability, evidence-based road safety interventions, and the SDG agenda.

Representing the local perspective **Regional Chapters**

The Alliance has established two regional chapters to respond more effectively to local contexts, leveraging regional needs and opportunities, cultural similarities, and members' realities.

The chapters are enabling us to work in a more targeted way with members and to connect them more closely with each other. Having a regional presence is opening doors for the Alliance and for grassroots NGOs with regional bodies, including the African Union and the Mercosur Parliament (PARLASUR), WHO regional offices, development banks, and legislator networks. This is not only a benefit for NGOs but offers insight for policy makers into what is happening on the ground in their region. Each region has a tailored call to action, reflecting its unique challenges and priorities.



AFRICA CHAPTER

The Africa Chapter's recognition among stakeholders is growing. This is reflected in the new opportunities in which it is increasingly involved, amplifying NGOs advocacy throughout Africa.

ASIRT-Kenya advocates the development and enforcement of regulations specifically aimed at school safety. A key aspect of its initiative is the proposal to reduce speed limits from 50 km/h to 30 km/h in areas where vehicular and pedestrian traffic intersect significantly. One of the best ways to do this is through networking with NGOs in the region, which generally share circumstances. According to Bright Oywaya, the organization's Executive



Director "being a member of the Alliance" has been of great value. The capacity building and networking that has happened has gone a long way in strengthening our organization. Working within the Africa Chapter, specifically, has had great benefits as we learnt from each other considering our similar backgrounds and challenges."



LATIN AMERICA CHAPTER

The Latin America Chapter has enabled greater engagement among Spanish-speaking members who benefit from increased opportunities to learn from and support one another.

In El Salvador, Alliance member MOVES convened a roundtable, supported by the Alliance, to enable dialogue between the UN Secretary-General's Special Envoy for Road Safety and the Vice-Ministry of Transport.

Movidana in Ecuador is one of the newest NGOs to join the Alliance and is pioneering a project to establish safe school zones in a local municipality. The project aims to reduce speed limits to 20 km/h and improve pedestrian facilities, especially for children and persons with disabilities. A key strategy is to engage local industries in redirecting their corporate social responsibility funds towards these interventions.

According to Paola Carvajal, Director of Movidana, "our incorporation in the Alliance has brought us enormous benefits. *Not only in the support for the* execution of specific projects, but also to be part of a large network committed to the same causes, whose experiences enrich our actions. The Alliance is our new big family."



ADVOCACY AND ACCOUNTABILITY

Genuine road safety action requires that governments meet their responsibility to reduce fatalities and serious injuries by 50% by 2030. NGOs can help by fulfilling their roles set out in the Global Plan, including their role in ensuring government accountability and promoting evidence-based interventions.

Advocating for evidence-based interventions Accountability Toolkit

The Global Plan for the Decade of Action for Road Safety 2021–2030 (Global Plan) clarified NGOs' mandate to hold their governments accountable for implementing road safety interventions based on evidence of what works, centering people to make road safety a human right. In order to realize this mandate with tangible actions, we developed the Accountability Toolkit. The toolkit offers a structured approach for NGOs to assess, prioritize, define, build a case, and track progress. It was launched at the Global Meeting in March 2023 and is being integrated into our programs and campaigns, backed with capacity building for NGOs, so that they can maximize the tools it offers.

The **Fundación Emilia** in Chile is working for the widespread adoption of 30 km/h zones, especially in urban areas, where lower speed limits have been shown to significantly improve pedestrian safety. To implement their strategy, they use the Accountability Toolkit to support their work in the Incubator Program. "The Accountability

Toolkit allows us to systematically and transparently monitor government policies related to road safety. It makes it easier for us to identify critical points that require immediate attention, allowing for more effective and focused intervention," says Javier Saavedra, Education Area Coordinator.

Stimulating and supporting in-country advocacy efforts #RethinkMobility campaign

The UN Global Road Safety Week brings together NGOs with the wider global road safety community under one call to action, giving greater strength to their voice. The 7th UN Global Road Safety Week was held under the theme #RethinkMobility, calling for a safe shift to walking, cycling, and public transport.

Using the Accountability Toolkit and the Priority Interventions, NGOs used the #RethinkMobility campaign to advocate for evidence-based interventions that make walking, cycling and public transport safe, including 30 km/h limits, pedestrian facilities, and traffic calming. During the campaign week in May, they organized activities to build community support and convince decision-makers to make tangible commitments to these life-saving interventions. Many NGOs' campaigns also demonstrated that, as well as saving lives, safe streets can also contribute to making people healthier, cities more sustainable, and societies more equitable.

People's Trust Jaipur's #RethinkMobility campaign highlighted the issues faced by women walking in the city. It conducted a safety audit with female students documenting the presence and absence of pedestrian facilities and the students' personal commuting experiences. It engaged city decision-makers to present the audit's findings and seek



improvements. Prerana Arora, CEO of the organization, assure that "we express our gratitude to the local implementing agency for taking proactive steps towards enhancing women and pedestrian safety in our community. Their efforts are invaluable in creating a safer and more inclusive environment for all residents."

Live from Leipzig

The second Live from Leipzig, held during the International Transport Forum (ITF), was the Alliance's global event for the UN Global Road Safety Week. A dialogue between the minister for transport in Chile, alongside ITF and an NGO, was live streamed from a tram traveling around downtown Leipzig, Germany. The symbolism of holding the discussion on a tram showed that public transport should be an option for everyone: including those who can afford other transportation systems.



ITF was chosen for the event because it is a meeting point of high-level decision-makers and practitioners from across the transport sector. It provided a highly visible opportunity for the Alliance to be a leading voice, representing members' call to action for safe walking, cycling, and public transport to facilitate sustainable and livable cities.

Leading globally coordinated advocacy Global Plan Anniversary

Each year, the Alliance holds an online accountability event called On Track or Off Target? on the anniversary of the launch of the Global Plan. The event is a checkpoint for progress towards the 2030 road safety target from a civil society perspective. The 2023 event introduced Mobility Snapshots, a new initiative to demonstrate what our streets are really like for the people who use them every day. The snapshots will be rolled out to NGOs in 2024 as part of a global advocacy push.

Promoting opportunities for NGOs to engage governments SDG Summit

A preliminary assessment of the SDG targets shows that only about 12% of countries are on track. Road safety is reflected in SDGs 3.6 and 11.2 and affects other issues, such as poverty, education, gender equity, and economic growth. Increasingly, together with our NGOs, we are seeing our advocacy in the context of how it enables other SDGs to be achieved.

In the lead-up to the SDG Summit, organized by the president of the 78th UN General Assembly and following the handover of the #RethinkMobility painting to the UN Secretary General (page 13), the Alliance published an open letter setting out the case to tackle the crisis on our roads and to rethink mobility.

"We urge you to take action to reduce road traffic deaths and injuries by 50% by 2030. How? By rethinking mobility and prioritizing road safety interventions that have been proven to save lives and reduce injuries... lower speed limits; 30 km/h zones where people walk, cycle, live, and play; and road infrastructure to protect pedestrians, such as speed bumps, footpaths, and raised crossings."

Providing support and strengthening NGO advocacy World Day of Remembrance

Every year the World Day of Remembrance for Road Traffic Victims (World Day of Remembrance) is commemorated by Alliance members at online and in-person events across the globe. This year, the #RethinkMobility painting, commissioned for the Global Meeting (page 11) and presented to the UN Secretary-General (page 14), was displayed as part of an exhibition held at the UN Headquarters in New York, demonstrating the need for safe and sustainable cities to prevent further lives lost.



Efthita Rhodes of Greece focuses on improving road safety and reducing road crashes. It promotes activities that improve road safety, road education, research, information and awareness-raising for vulnerable road users. "It is important to highlight the seriousness of recognizing the World Day of Remembrance by governments so that leaders understand that death and serious injury, including physical disability and that psychological trauma affects quality of life, autonomy, and the self-esteem of victims and their families" commented Eleni Karidi, president of Efthita Rhodes.

CAPACITY BUILDING

We equip NGOs with expertise and experience to fulfill their roles in contributing to reductions in deaths and injuries from road crashes and to build their professional credibility.

Helping NGOs achieve meaningful involvement in decision-making LEARN

The LEARN (Learn. Examine. Act. Replicate. Network) program, in collaboration with theInternational Road Federation (IRF) in Geneva, equips NGOs in Africa to build coalitions that bring together government officials, the private sector, academia, and NGOs for data-driven road safety projects. LEARN has now been implemented in six countries and LEARN Program: a guide for implementing has been published to support other road safety stakeholders in launching their own LEARN projects.



Convening member organizations for learning Research projects and publications

The Alliance conducts research into and publishes and contributes to publications on relevant areas to provide a data-driven approach to NGO advocacy. Our research provides an evidence base to strengthen NGOs' work in areas identified in our strategic plan and call to action.

AN ENABLING ENVIRONMENT FOR ROAD SAFETY NGOS

NGOs play a pivotal role in influencing governments' decision-making in road safety, bringing a unique community perspective, but they are not always able to participate meaningfully. A stronger enabling environment is needed to facilitate their involvement. The Assessment of the enabling environment for road safety civil society organizations in three Sub-Saharan African countries report looks at what makes an effective environment and provides a framework that can be applied with the view of strengthening NGO participation.

ASSESSMENT OF 30 KM/H URBAN SPEED ZONES

30 km/h speed limits are among the most effective ways of reducing road deaths and injuries, and NGOs have been advocating for their implementation for a long time. The research project "Assessment of 30 km/h urban speed zones and factors contributing to local modification for lower speed in Cameroon, Kenya, and Rwanda" examined where 30 km/h limits had been implemented on urban roads in these three countries to support advocacy and policy change in other places in Africa.


ADVOCATING FOR EMERGENCY CARE

Emergency care is an essential component of health systems and is critical for improving the quality of care provided to patients, including those injured from road traffic crashes. The Alliance collaborated with WHO on its publication Advocating for Emergency Care: a guide for nongovernmental organizations, which provides simple steps that NGOs can take to identify effective emergency care interventions and to advocate for their implementation. The steps are backed up by practical case studies, including a number from Alliance members.


